Mr. Joslin stated he was involved in some criminal activity with Mr. Dawson and Mr. Dawson accused him of being a snitch in that case. Mr. Joslin stated that Mr. Dawson stated he would kill him if he did not sign his vehicle over to him. Mr. Dawson stole a computer and camera from the residence. At 1954 hrs. ### INITIATING INFORMATION

On 04/18/07, at approximately 1220 hours, the Colorado Springs Police Department received a telephone call from an employee of Memorial Hospital in reference to a First Degree Assault. It was reported that Victim #1 was at the Emergency Room of Memorial Hospital suffering from a laceration to his forehead.

At 1241 hours, I, Officer J.D. Walker 483P (5A53) was dispatched to the Memorial Hospital Emergency Room in reference to an assault. It was reported to me that the victim had sustained a head injury from a suspect identified as **KENNETH BRYAN DAWSON**, DOB 10/17/84. It was reported that the assault took place at 2311 Robin Drive.

At 1255 hours, upon arrival, I contacted Security at Memorial Hospital who directed me to Emergency Room #3. When I arrived to this portion of the hospital, I observed a white male lying on his back with a large laceration on his forehead, which appeared to be the result of blunt force trauma. The laceration sustained by the victim was approximately 1 " long. The victim was bleeding from the forehead and appeared to have blood all over his hands. The victim was being attended to by medical personnel. There was a lady inside the room, identified as **PAT JOSLIN**, (mother to the victim). I asked Ms. Joslin to step out of the room so that I could conduct an interview with her.

### **VICTIM'S MOTHER INTERVIEW**

Ms. Joslin stated that this situation dates back to the Summer of 2006. Her son, the victim was arrested for Theft by Receiving and Motor Vehicle Theft of a motorcycle. Ms. Joslin stated the case is still pending with no final disposition as of this date. Ms. Joslin stated that Kenneth (Bryan) Dawson was also involved in the same case.

On 04/18/07, Ms. Joslin reported that she was at work at Memorial Hospital at approximately 11:30am when she received a telephone call from her son stating that he needed to go to the hospital. Ms. Joslin stated that the victim told her that Bryan was at the house and hit him in the head and tased him. Ms. Joslin told me that the victim told her that Bryan took her computer and a digital camera and told **JUSTIN JACOB JOSLIN**, DOB 01/08/88 that he needed to sign over the title to his vehicle and at that time he would give the computer and camera back. Ms. Joslin stated that her son told her that Bryan would kill him if he does not do what he says.

Ms. Joslin stated she left work and went home and discovered her son bleeding profusely from his forehead. Ms. Joslin stated she rushed him to the Memorial Hospital Emergency Room. I asked Ms. Joslin to clarify what she observed when she went into her residence. Ms. Joslin stated that when she got home her son was on the couch bleeding from the forehead. Ms. Joslin stated that Justin told her that Bryan had hit him in the head with a padlock and chain and tased him several times on his arms and legs. Ms. Joslin stated that Bryan did not have permission to be in her residence and did not have permission to take her computer or camera from her residence. Ms. Joslin stated the camera was a Power shot Canon digital camera model A530 valued at \$200.00, the computer was a brand new H.P. Pavillian model RK573-AA-A3A serial number CNH6511LC4, valued at \$1000.00 Ms. Joslin stated the camera and computer belonged to her.

victim had sustained injuries which were consistent with serious bodily injury resulting in permanent disfigurement to his forehead. Dr. Loehr also reported that the victim had sustained several burn marks on his legs and arms consistent with being tased multiple times. Dr. Loehr stated that the victim was lucky to be alive and that he sustained blunt force trauma to his forehead and that the victim would receive approximately nine sutures.

### **VICTIMS STATEMENT**

At 2:00pm, I spoke with the victim, who was lying on a hospital bed. Justin told me that at about 11:15am this morning he was sleeping when he heard a knock on the door. He stated he looked out the window and saw a male in a leather jacket that he thought was one of his friends. Justin stated he went to the front door, opened the door, and discovered that it was Bryan Dawson. He stated Dawson was with a second person that he did not know. Justin stated that both persons walked into his residence as he was backing up toward the living room. Justin stated that when he got to the living room area, Dawson said something to the effect of, "Why did you tell the cops, and why did you snitch on me?" Justin stated at the same time Dawson was saying this he (Dawson) pulled a taser from his right coat pocket and started tasing him. Justin stated he went to the couch, sat down, as Dawson continued to repeat, "Why did you snitch on me?" Justin stated that he kept telling Dawson that he did not snitch on him, but Dawson kept tasing him. Justin stated that Dawson tased him 15-20 times.

Justin stated that the second person, described as a white male, 5'9", 120-130 pounds, with a black goatee and spiked black hair, picked up his mother's camera bag from the foot rest, removed the camera from the bag and stuck it into his pocket. Justin stated at that point Dawson pulled out a chain with a padlock on the end of it from his right pants pocket and as he was lying on the couch on his back, Dawson struck him with a backhand motion, causing the padlock to strike him in the head. Justin stated it immediately started bleeding. At that time Dawson told Justin, "You're lucky that's all you got." Justin stated that Dawson then told him that he had to sign over the title to his car and if he didn't do that or if he went to the cops he was going to kill him. Justin stated that Dawson said, "I will shoot you in the face, I will fucking kill you." Justin stated Dawson unhooked the computer (CPU) and told him, "When you sign the title of your car over to me, I will give back the computer and camera."

Justin stated as he was laying on the couch his brother JETT came out of his bedroom. Justin stated that Dawson told Jett, "Your brother snitched on me. I don't have a problem with you." Justin stated that Dawson looked at him and stated, "What do you think I've been doing? I'm taking care of people that snitched on me." Justin stated that his brother, Jett, then noticed that he was bleeding from the head, as Dawson and his friend were going out the front door with his mother's computer and camera.

Justin stated that he had learned from his neighbor, DOUGLAS HAHN, from 2321 Robin Drive, that the suspects left in a green Saturn. Justin stated that he never did see the green Saturn in front of the residence and believes that they parked the vehicle on the north side of his residence by his garage. Justin stated that he never invited Dawson and the other male into his residence and that he was in fear for his life. Justin stated that Dawson threatened to kill him, and that he believes that Dawson will try to carry that out. Justin stated that Dawson has had guns in his possession in the past. Justin described the chain with a padlock as having approximately 10 links, about the size of a tire chain, with what he thought was a Master Lock on the end.

### WITNESS STATEMENT

At 2:45 p.m., I contacted Mr. Hahn at 2321 Robin Drive. Mr. Hahn stated that he observed a green Saturn parked up against the garage and fence area of the victim's residence. He stated that he observed two males walking toward the front door of the victim's residence. Mr. Hahn told me that although he did not see their faces, he believes that one of the individual's was a person by the name of Mr. Dawson, who he had completed a witness statement against for a motor vehicle theft.

exterior to include tire tracks located on the northeast side of the victim's residence. I pulled a criminal history for Kenneth Dawson and determined that he was arrested for Motor Vehicle Theft on 02/21/07, on Colorado Springs Police Department Case Report #07-04122. I contacted the on-call Judge for a bond increase due to the defendant's criminal history, the fact that he is presently out on bond, and that this appears to be a crime of retaliation. I spoke to **Magistrate Lisa Kirkman**, who increased the bond to \$50,000, due to the above mentioned circumstances.

At approx.1800 hrs. I received a call from Officer Dan Mork who was familiar with Mr. Kenneth Bryan Dawson. Officer Mork advised me that he thought he could find Mr. Dawson in the Sand Creek area. I gave Officer Mork information about my case and the description of the second suspect. I also advised Officer Mork of the items that had been stolen from Ms. Joslin. At approx. 2000 hrs. Officer Mork called me and advised me that Mr. Dawson was incustedy. I contacted Sgt Lux and had the probable cause affidavit transported to the Sand Creek Division. Officer Mork advised me he was going to write a search warrant on the residence of Mr. Dawson in reference to the stolen property and the weapon used in the attempted murder case. See supplements from other officers.

### INITIATING INFORMATION

On 04-18-07 at approximately 1700 hours, I (Officer D. Mork, 1763P) was working patrol in the Sand Creek Division when I was able to view pending calls request on my car's computer and observed that there was a pending call for an attempt to locate for **KENNETH BRYAN DAWSON** (DOB 10-17-84) at an address of 152 W. Rockrimmon Boulevard #104. I was aware that this address was Mr. Dawson's mother's address. It showed on the screen that Mr. Dawson was wanted to attempted first degree murder and the investigating officer was **Officer J. D. Walker**, 483P.

## **OFFICER STATEMENT**

I was very familiar with Mr. Dawson and arrested him on several occasions and had been involved in several of his cases and believed that I would be able to find a current location or residence for Mr. Dawson. I decided to contact Officer Walker at the Stetson Hills Division and informed him that I may be able to contact people that would know where Mr. Dawson would be located at. Officer Walker informed me that he would be appreciative of that and stated to me that he would hold off on sending officers to Mr. Dawson's address so that I could make the attempt.

Within approximately 15 minutes I was able to make a phone call to a concerned citizen who wished to remain anonymous who was also an acquaintance of Mr. Dawson. That concerned citizen was able to inform me that for the last three days Mr. Dawson had been staying at "POE's" house near the intersection of E. Fountain Boulevard and Aeroplaza Drive. I was aware of this address due to the fact that it was an address that Mr. Dawson had frequented on a previous investigation. I was aware that "Poe" was actually ALEXANDER POE (DOB 10-27-82) and that his current address was 5150 Dovetail Lane.

I also learned from Officer Walker that Mr. Dawson was seen in a green in color Saturn during the commission of the crime earlier in the day on 04-18-07 and I also learned from my concerned citizen that Mr. Dawson had been driving a blue or a green Saturn sedan that belonged to a girl by name of **NANCY**.

I then contacted **Officer E. Gulbrandson**, 1860P, and informed him of the pending charges of Mr. Dawson and asked if he wanted to conduct surveillance with me at 5150 Dovetail Lane. Officer Gulbrandson and I then decided to go over to that address and conduct surveillance for approximately one hour.

It should be noted that I initiated my contact with Officer Walker at approximately 1900 hours not 1700 hours on 04-18-07.

At approximately 1954 hours on 04-18-07 I observed a green in color Saturn sedan drive into the north driveway on Dovetail Lane approaching 5150 Dovetail Lane. I observed the vehicle was occupied by a white male driver but could not get positive identification due to the distance that I was from the vehicle. I was able to decrease distance between my vehicle and the suspect vehicle as I observed the vehicle pull into the north side parking lot beside 5150 Dovetail Lane. I was able to observe that the driver was indeed Kenneth Dawson (DOB 10-17-84). I exited my police vehicle and immediately placed Mr. Dawson at gunpoint and ordered him to the ground. Mr. Dawson was cooperative and immediately went to the ground and was placed into custody without any incident.

During a search incident to arrest of Mr. Dawson I recovered the following items. ...

One Uzi 650,000 volt stun gun that was black in color in a black nylon pouch recovered from Mr. Dawson's left inside jacket pocket

One set of car keys to the Saturn he was driving and on those keys were two residential or house keys connected to the key ring

I also recovered multiple items of personal property belonging to Mr. Dawson, to include an additional key chain with keys, a black flashlight, a blue folding knife, and a black cell phone.

The license plate on the vehicle that Mr. Dawson was driving was 990OLX, Colorado, which listed to a green 1992 Saturn SL1 to **URITZA KING** at 414 Easthills Road, Colorado Springs, Colorado 80909.

Officer Gulbrandson was able to complete a search incident to arrest of the passenger compartment of the vehicle and items of evidence were recovered from the vehicle. Please see supplement by Officer Gulbrandson reference those items. It should be noted that during the search of the vehicle officers did not locate items that had been taken from the previous crime documented by Officer Walker that had been taken from the victim to include a gray and silver Hewlett Packard computer and a Canon digital camera.

I was able to run Alexander Poe (DOB 10-27-82) through NCIC/CCIC and discovered that he had an outstanding felony warrant in CCIC for failure to appear on a charge of unlawful possession of a schedule II controlled substance. Both Officer Gulbrandson and I suspected that Mr. Poe was inside of 5150 Dovetail Lane due to the fact that several lights were on in the house and that several of the windows were open at the time. Officer Gulbrandson and I also suspected that inside of the house were possibly items that had been taken and used in the commission of the crime investigated by Officer Walker. It was also determined that Mr. Dawson was highly uncooperative and refused to answer any questions to officers to include personal information questions such as name, date of birth, and address. Due to the fact that Mr. Dawson had keys with him some of which were residential keys, I suspected that one of the residential keys would unlock the entry door to 5150 Dovetail Lane. I was able to take the key ring with one of the keys and go to the north side entry door of 5150 Dovetail Lane and use the key to unlock the door but I did not open the door.

Based upon information received from my concerned citizen, as well as the fact that Mr. Dawson had keys to 5150 Dovetail Lane and officers believed that there was evidence inside of 5150 Dovetail Lane that would be crucial in this investigation, **Sgt. A. Butierres**, 289P, was summoned and brought to the scene to assist and all parts of the current investigation were supervised by him. After discussing the circumstances involved in the case, it was decided that I would go and apply for a Search Warrant for 5150 Dovetail Lane in an attempt to remove any suspected items involved in this case from the residence. I then transported Mr. Dawson to the Sand Creek Substation for paperwork and processing. Also while at the Sand Creek Substation I contacted Officer Walker by phone to obtain an exact list of items taken by Mr. Dawson in the original case and also to obtain the items of clothing and also weapons used during the commission of the crime. Officer Walker was able to provide me with detailed information about the computer and phone that had been taken from the residence, and he also provided information about the weapons used and clothing worn by the two suspects.

Based upon that information I did apply and obtain and Search Warrant at 5150 Dovetail Lane. That warrant was signed on 04-18-07 by the **Honorable Magistrate Kirkman** at 2324 hours on 04-18-07. I then responded to 5150 Dovetail Lane where Officer Gulbrandson, **Sgt. J. Kern**, 1517P, who had replaced Sgt. Butierres, and additional Colorado Springs Police Department officer were on scene to maintain the perimeter of the residence.

Upon arrival at 5150 Dovetail Lane, Officer Gulbrandson, Sgt. Kern, and I executed the warrant and completed a sweep of the residence for any and all persons. During that sweep I located Alexander Poe hiding in the southeast bedroom closet lying on the floor near the middle of the closet. I placed Mr. Poe at gunpoint and ordered him out of the closet. Mr. Poe was placed into custody without any incident. It was later determined during a search incident to arrest of that closet, Officer Gulbrandson discovered a black Mossberg 12-gauge shotgun, serial #MVB1932F, in that closet within reachable distance of Mr. Poe when he was placed into custody.

Once Mr. Poe was in custody for his outstanding warrant, he was transported to an awaiting Colorado Springs Police Department vehicle and officers continued the sweep of the residence. No other persons were located inside of the residence. I did locate during the sweep a large 3-foot by 3-foot by 3-foot gray safe in the northeast upstairs bedroom that I suspected to be the bedroom belonging to Alexander Poe. I did check the safe to see if the safe was unlocked and I determined that the safe was locked. Once completed with the sweep of the residence, I went out to where Mr. Poe was seated on the north side of the residence. I informed Mr. Poe that during the execution of the warrant it would be necessary for offices to make entry to the safe and if he wanted to provide the combination to the safe in order to not require officers to force entry to the safe causing damage to the safe. Mr. Poe refused to give the combination to the safe.

It should be noted that during the initial protective sweep of the residence, we discovered an upstairs bedroom that was locked with an exterior deadbolt and in order to gain entry I was required to force entry on the door breaking the door jamb. This was later documented in a damage to non-police property report (unknown number at this point).

Prior to searching the residence, Officer Gulbrandson did take several digital photographs of the interior and exterior of the residence.

During the search of the residence, I recovered the following items:

One El Paso County District Court paperwork belonging to Alexander Poe recovered from an ironing board in the northeast bedroom.

One small clear plastic Ziploc baggie containing a white crystal substance suspected to be methamphetamine, which later field-tested positive for methamphetamine on 04-19-07 at 0443 hours, located under the bedroom mattress in the southeast bedroom.

Both Officer Gulbrandson and I located multiple glass pipes to smoke both suspected methamphetamine and marijuana from various locations within the residence.

I also recovered one triple beam balance scale from the master bathroom floor.

I also recovered approximately \$521.00 in U. S. Currency that was in two envelopes on a pin board on the side of the gray safe located in the northeast bedroom closet.

I also recovered one large gray safe that entry was later forced into. Inside the safe was one green colored ammo canister containing miscellaneous items belonging to Mr. Poe and one Lightning Audio brand capacitor. All items in the safe were put in for personal property for Mr. Poe.

I also recovered one Canon Powershot model A620 digital camera, serial #1026129271, from the downstairs living room table.

I also recovered one black leather jacket, the make of the jacket is Pelle Studio size XL, recovered from the south side front entry door closet of the residence.

All of these items were recovered and later placed into evidence or personal property and a copy of the evidence invoice is attached to the investigations copy of the face sheet.

It should be noted that during the initial scope of our Search Warrant officers located items consistent with the distribution and sales of narcotics to include clear plastic baggies, weigh scales, U. S. Currency, and suspected methamphetamine. I did go and amend the original Search Warrant to allow officers to seize suspected firearms, narcotics, and narcotic packaging materials from the residence. That warrant was also signed by the Honorable Magistrate Kirkman at 0141 hours on 04-19-07. All items were seized from the residence after the second Search Warrant was signed.

That is when officers noted the various items of personal property within the safe. Once completed with opening the safe, officers responded back to the Sand Creek Substation where Officer Gulbrandson and I processed and placed several items of evidence and personal property into evidence and personal property.

Also on 04-19-07 I was able to complete a Report of Execution for the Search Warrants completed at 5150 Dovetail Lane. ### INITIATING INFORMATION

On 04/18/07 at approximately 1900 hours, Officer D. Mork, 1763P, advised me that Kenneth Brian Dawson, DOB: 10/17/84, was wanted for attempted first degree murder where he attempted to kill **Justin Joslin**.

Last summer, Officer Mork and I did a lengthy investigation in which Kenneth Dawson was the focus of the investigation for numerous motor vehicle thefts. While investigating Mr. Dawson, we arrested Justin and Jeremiah Joslin for possessing stolen motor cycles. Justin and **Jeremiah Joslin** also provided us useful information in building the case against Kenneth Dawson for numerous motor vehicle thefts. We believe that Kenneth Dawson was seeking retaliation against the witnesses against him in those cases and that is why he was targeting Justin Joslin.

Officer Mork also received a tip that Kenneth Dawson was staying at 5150 Dove Tail Lane where an associate of his, who we knew from the past, lived. This associates name is Alexander Poe. We also knew that Mr. Dawson had stayed with Poe in the past when he was on the run from the police. Officer Mork and I set up surveillance at Mr. Poe's address where we eventually arrested Kenneth Dawson and found evidence related to the crime.

## OFFICER STATEMENT

NARRATIVE

VER DSOFT 12/28/04

Officer Mork received information from an informant that Kenneth Dawson was staying with Alexander Poe at 5150 Dove Tail Lane and was driving a green or teal Saturn. 5150 Dove Tail Lane is a town home in a town home complex. There are three entrances to the town home complex that all run off of Aeroplaza Drive. We set up surveillance where we could see all three entrances into the town home complex. At 1954 hours, Officer Mork observed a green Saturn pull into the town home complex. I also observed this vehicle and followed. It went directly to 5150 Dove Tail Lane. As we parked, Officer Mork positioned his marked patrol car behind the vehicle and the driver, Kenneth Dawson, exited and was taken down at gunpoint. The suspect complied with Officer Mork's commands and was proned out face down beside his vehicle. Officer Mork then handcuffed the suspect and placed in the back of his patrol car. Officer Mork also found evidence relating to the attempted first degree murder case which was a taser or stun gun found in the suspect's coat pocket.

Officer Mork and I then searched the green Saturn that Mr. Dawson was driving. Prior to the search, I photographed the exterior and interior of the vehicle with my digital camera. Upon conducting a search of the vehicle, I recovered a silver colored dog choke chain from the center console of the vehicle after receiving information that the victim in this case was beat with a chain of some kind. Also, in the suspect's possession were house keys to 5150 Dove Tail Lane. The key for the Saturn was attached to these keys. I eventually removed the key for the Saturn from the key chain and gave it to the Randy's tow truck driver when the vehicle was impounded. Upon searching the trunk of the vehicle, I found a size 44 blue denim jeans with yellow stitching on the rear. I observed red stains located on the top portion of the jeans by the right pocket that appeared to be blood. These items were placed into evidence at the Sand Creek Substation.

Officer Mork then contacted the initiating officer in this case, Officer J.D. Walker, 483, by phone. I also spoke to Officer J.D. Walker over the phone and asked what the suspect was wearing during the crime. Officer Walker explained to me that the suspect was wearing a black leather jacket, blue denim jeans, unknown shirt, and unknown shoes. Officer Walker also explained that there were items taken during the assault. Officer Walker explained that there was a Canon digital camera, as well as a Hewlett Packard Pavilion CPU (computer), taken in ...

Officer Mork and I, as well as Sgt. A. Butierres, 289P, tried to make contact at 5150 Dove Tail Lane. We knew that the resident, Alexander Poe, was wanted for a felony drug charge. After knocking loudly on both the front and rear doors, we received no answer. We then decided to apply for a Search Warrant for the residence, thinking that items either used in the crime or taken in the crime were inside the residence since information stated he was staying there. Officer Mork then transported Mr. Dawson to the Sand Creek Substation and completed a Search Warrant for the residence. I stayed behind along with Officer E. Keck, 3175P, to secure the residence.

While performing security for the residence at approximately 2239 hours, Officer Keck advised over the radio that two females were coming out of the front of the residence. We went to contact these two females, identified as Miranda Garcia, DOB: 08/22/86, and Haylee Keating, DOB: 09/10/87. I spoke to the two females and Miranda stated she was the cousin of Alexander Poe who lived at the residence. Ms. Keating was a friend of Miranda's and was just there hanging out with Miranda. I asked Miranda how long they had been there and she stated they had been there since 8 or 9 this morning. I asked her if her cousin, Alex Poe, was in the residence and she stated she didn't think so. She stated they were in the basement the entire day and didn't go upstairs. I informed them that I had been in the residence previously and knew that the basement was unfinished and there wasn't much down there. I asked them if they went upstairs to get a drink of water or get something to eat and they stated they did but they did not go upstairs and did not know if Alexander Poe was inside. Miranda stated that there was a lock on Poe's door to his bedroom and she doesn't go inside. She then pointed to the upstairs window, which we could see from the outside, and stated that was his bedroom. This is the bedroom on the northeast corner of the residence. I then asked the two females if they knew Kenneth Dawson, who goes by the name Brian, and described him to them. They stated they had not seen him and do not know who he is. After checking the two girls for any warrants, and found none, they were released. They then left in a vehicle bearing Colorado license plate 439LEA which registered to Miranda's father.

Because the girls seemed to act somewhat suspicious and unclear whether Alexander Poe was still inside or not, I believed he was still inside the residence. Officer Keck and I continued to wait outside until the warrant was signed for the residence. At 2330 hours, Officer Mork advised over the air that the Search Warrant h ad been signed for the residence and he was enroute to our location. At 2346 hours, Officer Mork and Sgt. J. Kern, 1517P, completed a search of the residence.

Prior to entering the residence, I knocked very loudly on the rear door. We then used the house key that was recovered from Kenneth Dawson to enter through the rear door. I unlocked the rear door and opened it and again announced two times that we were the Colorado Springs Police Department and we had a Search Warrant for the residence; if anyone was inside to announce themselves. We received no reply from inside. Officer Mork and I had been in the residence previously and knew that there was a stairway leading to the upstairs directly inside the front door and there was a stairway leading into the basement off of the kitchen area. Officer Mork and I and Sgt. Kern cleared the first level and then went upstairs. While clearing the southeast bedroom, I heard Officer Mork giving commands to someone to put their hands out and to lie directly on the floor. The party complied and I immediately recognized this person as Alexander Poe. Mr. Poe was placed into custody. I noticed there was a lock on the northeast bedroom door. I asked Mr. Poe where the key was to the door and he stated it was his parent's room and he didn't know. Officer Mork and I both knew that his parents did not live at the address even though they are the owners of the home. Officer Mork and I then asked him at least three more times where the key was and if we don't find the key, we're going to kick that door in. Mr. Poe continued to say that he did not know where the key was for that door. Officer Mork then kicked the door open and we cleared the bedroom and found no one else inside.

After clearing the entire residence, Officer Mork and I began the search of the residence. Mr. Poe was placed in the back of a police car and Officer Keck stayed with him. Prior to searching the residence, I took digital photographs of the residence. Also during the search of the residence, I photographed items that we recovered during the search. I started my search in the southeast bedroom where Mr. Poe was found hiding. I started in the closet area. Inside the closet where Mr. Poe was hiding, I recovered a Mossberg 12 gauge pump shotgun, serial #MVB1932F. I noticed this was a very short shotgun with a sawed-off barrel and also the stock had been cut to have a pistol grip. The weapon was unloaded when I recovered it. I again photographed the weapon ...

where it was found and the serial number of the weapon. Also recovered from the closet where he was hiding were numerous glass pipes with white residue, commonly used to smoke methamphetamine. Also found in the closet was court paperwork and letters to and from CJC. These letters belonged to an **Aahren Shaw**.

On the desk in the southeast bedroom, I found a Hewlett Packard Pavilion CPU computer with serial #CNH6511LC4. This computer was not hooked up to anything and had no attachments whatsoever on the computer. This computer was later found to match the serial number of the computer taken during the attempted murder/first degree burglary. I also found a silver colored chain with a padlock attached to one end on the top shelf of the closet where the firearm was found.

Because we were finding narcotics paraphernalia, as well as suspected narcotics and a firearm inside the residence, it was decided that Officer Mork would amend the original warrant to include these items. At the time, we believed Alexander Poe was a previously convicted felon and was not allowed to have or possess a firearm. Because the firearm was also sawed off, it appeared to be an illegal firearm. When Officer Mork amended the original warrant, Sgt. Kern and I stopped the search and waited with Mr. Poe seated in the kitchen for the amended warrant to be approved. While we were waiting, I attempted to interview Mr. Poe.

## ARRESTEE STATEMENT

I read Mr. Poe his Miranda Rights from a card which I carry with me. I asked him if he understood the rights I had explained to him and he stated yes. I then asked him who was staying with him at the residence. He stated that a guy named Aahren was staying with him. I asked him to explain what Aahren looked like and he said Aahren was a black male. I explained to Mr. Poe that all the information we had of who was staying with him, no one described a black male staying with him. Mr. Poe stated he was very light skinned, possibly Puerto Rican.

I then asked how long Dawson had been staying with him. Mr. Poe never gave me a direct answer and then stated that h should talk to his attorney before he answers any questions. I then stopped the interview and did not ask him anymore questions relating to the crime.

### OFFICER STATEMENT CONTINUED

After questioning Mr. Poe, he was then transported by Officers Juhl and Silveira to CJC where he was booked in on his warrant. Sgt. Kern and I continued to wait for the amended warrant to be signed.

At approximately 0155 hours, Officer Mork advised that the warrant was signed and he was enroute back to our location. Officer Mork and I then collected the items we had each found in the residence and placed them in the trunk of my cruiser. We also carried the safe recovered from Poe's bedroom closet and put it in Sgt. Kern's cruiser. After the search was complete and all the evidence was removed from the house, we then went to Colorado Springs Fire Department (CSFD) Station 17 where they have a Heavy Rescue unit. Thinking that there may be more evidence to the crime to be investigated in the safe, we asked if they could open the safe for us. Firefighters opened the safe by cutting off the door to the safe with a pneumatic chisel. Once the door was opened, there was nothing of evidentiary value found in the safe. There was \$4; two \$1 bills and one \$2 bill, as well as miscellaneous items found inside. These items, including the safe, were placed in Mr. Poe's personal property to be picked up at a later time by him.

After the safe was opened by CSFD, Officer Mork and I then transported all the evidence to the Sand Creek Substation to be processed. When then divided up the evidence and processed it. We also opened up a new case under case #07-13054 titled Possessing a Dangerous or Illegal Weapon, 18-12-102, a Class Five Felony. In this case, Alexander Poe was the suspect and he would later be charged for this, as well as Possession of a Schedule II Controlled Substance (methamphetamine) which we found in the room where he was hiding.

It should be noted that these items were seized because we originally thought that we found a large quantity of illegal narcotics and we thought that Mr. Poe may be distributing narcotics. It was later found that the item found which we thought was narcotics was not in fact narcotics so these items were placed as personal property.

Also placed into evidence was a CDR disk containing the photographs which I had taken of Kenneth Dawson's vehicle, the items recovered inside, as well as items recovered from inside the residence during the search.

On 04/19/07, I went to the evidence unit to measure the shotgun recovered from the closet in the southeast bedroom. I found that the barrel length from the end of the barrel to the receiver was 15 1/2 inches and overall length of the shotgun was 28 inches. Officer Mork then completed a Probable Cause Affidavit for Alexander Poe to charge him with Possessing a Dangerous or Illegal Weapon as well as Possession of a Schedule II Controlled Substance. I later took that Probable Cause Affidavit to CJC to add it to his original warrant charge that he was booked on.

On 06/02/07 at 0742 hrs, I Officer M. Watson, 9613 was dispatched to assist Falcon Division for a call for service. Mr. Richard Lee Salaz, dob: 05/13/63, was taken into custody for Domestic Charges and outstanding warrants.

While transporting Mr. Salaz to CJC, he asked me if CSPD was still looking for two guy's named Dawson and Spider. I told him the two name were not known to me. Mr. Salaz said the two men were wanted for a murder that took place about 3 months ago. I asked Mr. Salaz if he knew where the men were and he stated yes. I asked him if would tell me where and he said no. I asked him if he wanted to talk to any Detectives about the Dawson's and Spider's location. Mr. Salaz said no. Nothing further was said until we arrived at CJC.

While processing Mr. Salaz into CJC, Mr. Salaz stated that maybe he would like to speak to a Detective about Dawson and Spider, if he could get the charges, he was being book on dropped. I told Mr. Salaz that I could call the detectives for him, but I could not make any promises about any charges being dropped. I told him a decision like that would rest with the District Attorney Office only.

Mr. Salaz said he would only talk if he could get his charges dropped. I told him that would not happen. Mr. Salaz then said, ok he would like to talk to a Detective. I told him I would contact the Detectives and they may come out today, 06/02/07, to talk to him or they may wait until Monday. Mr. Salaz said he would wait until Monday.

After Booking Mr. Salaz into CJC, I want to my police car to determine if anyone named Dawson and Spider were wanted by CSPD. I was able to contact Officer J.D. Walker,483P. Officer walker said he was working a an Attempted Murder case, involving a Dawson and a Spider. Officer Walker asked me to go and speak to Mr. Salaz and attempt to obtain any information fro Mr. Salaz.

I returned to CJC and spoke to Mr. Salaz. I told him that I had spoken to the Detectives and they asked for me to speak to him. I told Mr. Salaz that the Detectives needed some reliable information from him before they would act on any thing. Mr. Salaz asked about his charges being dropped again. I told him that I can't make any promises, but that would be up to the DA's Office.

Mr./ Salaz said Dawson and Spider hang out at his sisters house. I asked him where she lived and he would not tell me. He said she was involved in the "Robbery" of Kohl's Department store, Located on N. Powers and N. Carefree. I asked Mr. Salaz how he knew about Dawson and Spider. He said he was at his sisters house a few weeks ago and he overheard Dawson telling his sister that he had struck a man in the head with a chain and a large lock. Mr. Salaz said he knows that the man name Spider did not do anything, but he was there. Mr. Salaz continued and said Dawson always goes to his sisters house to hid from the police. Mr. Salaz said Spider will drop off Dawson about a block away from his sister house and he would walk the rest of the way. Mr. Salaz said Dawson did this so the police would not find him. Mr. Salaz said Dawson and Spider are always together too. I asked Mr. Salaz where his sister live. He was again hesitant to tell me, but he said she lived at 3708 Meadowland Blvd.

Mr. Salaz said he did not know the real name of Spider, but he described him as a: **Hispanic male, 5-10/11, 180lbs, with a shaved head and a mustache and a goatee. Mr. Salaz said Spider drives a red 1992/93 red Camaro**, unknown license plate. Mr. Salaz had nothing further to add to his statement.
