NARRATIVE

On September 22nd I, Officer Hulon, responded to 39 Hill St in reference to a stalking incident. Upon arrival I met with the victim, identified as KIMBERLY TANAKA. Kimberly stated she had just found a tracking device under her car at her private investigators office, 570 W Crossville Rd (AFPI GLOBAL INVESTIGATIONS).

Kimberley advised that she thinks her being stalked started in January of this year. She hired a private investigator. While she was at the private investigators place, they noticed a suspicious vehicle nearby (A Black Mercedes with two white males in it, 50 to 60s). They looked under her vehicle and found a GPS tracking device with a magnet. The males then drove away.

Kimberley advised that she believes a man named PAUL HAMRICH, in his 50s, is behind the stalking. She stated she works at Catalyst Fitness and that some of her clients are VIPs. She stated that she believes they are trying to get to one of those VIPs through her.

A case number was generated for her. She was advised that the matter would be turned over to CID to investigate. The GPS was taken to evidence. Nothing further to report at this time.
